



- China publishes services PMI, Asian stocks mixed. In Japan, the Nikkei 225 fell 0.27%. The Chinese market fell with Shanghai Composite down 0.36%, Shenzhen Component down 0.651%. Hong Kong's Hang Seng fell the most in the region, losing 1.46%. Only South Korea's Kospi index rose 0.72%.

- Information from the Ministry of Planning and Investment, in the first 5 months of the year, industrial parks and economic zones attracted 291 foreign investment projects with newly and additionally registered capital reaching about USD 6.02 billion, an increase 10% more than the same period last year. At the same time, the number of newly registered and adjusted projects from domestic capital is 271 projects worth VND 53,200 billion.



Content - MBB: The State Bank allows MB to increase charter capital up to nearly 9,800 billion VND from accumulated profit after tax. MBB plans to have 2 other capital increases including offering to strategic shareholders and issuing ESOP shares.

- PDR: Phat Dat survey to do industrial, service and urban zone project in Ba Ria - Vung Tau
- PLX: continued to be net bought by foreign investors in today's session, but the value has decreased significantly, only 28 billion dong.
- VIC: Vingroup proposes tax incentives for electric cars for 5 years

- HPG: Information on the purchase of 5 million HPG shares by Mr. Tran Vu Minh, son of Mr. Tran Dinh Long - Chairman of the BOD announced on May 18 was forced to stop by the State Securities Commission. The reason given by the Committee is that the Resolution of the Group's 2021 Annual General Meeting of Shareholders has not clearly identified the transferee as prescribed in the Law on Securities 2019.
