

- In the first 5 months of 2021, remittances flowing to Ho Chi Minh City still reached 2.6 billion USD, up 13% over the same period. This is a positive figure in the context of the difficult market due to the Covid-19 epidemic. Previously, remittances flowing to Ho Chi Minh City in the first 4 months of this year reached 2 billion USD, up 11% over the same period last year.



Content - CTG: The bank said it will issue bonds to the public in 2021 with a total value of VND 10,000 billion. These bonds are eligible to be included in the tier 2 capital increase. Issuing bonds to increase the scale of operating capital, lending to the economy, increasing tier 2 capital and ensuring capital adequacy ratios.

- PDR: PDR has transferred 99.5% of the contributed capital of shareholders in Binh Duong Building Investment and Development Real Estate Joint Stock Company on June 3, 2021.
- Oil prices have been continuously increasing recently in the context of improving demand prospects and this momentum may continue in the summer.
- VIC: In total, Vingroup spent nearly 100 million USD on COVID-19 prevention and control, half of its profit in 2020
- VNM: PLATINUM VICTORY PTE. LTD. Did not buy any shares out of nearly 21 million shares registered to buy. Trading time from 05/05/2021 to 03/06/2021
- SSI: The Board of Directors of SSI approved the implementation of the stock bonus plan and offered it to existing shareholders. The total issuance volume under these two options is 328.65 million shares. The offering plan to shareholders has a price of 10,000 VND/share, expected to earn 1,096 billion VND.
