- The Dow Jones index fell for the second consecutive session on Thursday (June 17), as investors received the latest policy update from the Fed, in which the agency has raised inflation expectations and increased the time frame on when to raise the next interest rate. At the end of the session, the Dow Jones Industrial Average fell 210 points (0.62%) to 33,823.45 points, while the S&P 500 Index fell 0.04% to 4,221.86 points. Meanwhile, the Nasdaq Composite index advanced 0.87% to 14,161.35 points



- Credit institutions shall be rated (D) if falling into one of the following: failing to maintain the solvency ratio specified at point a, clause 1, Article 130 of the Law on Credit Institutions (which has been amendments and supplements) for 03 consecutive months; failed to maintain the capital adequacy ratio specified at Point b, Clause 1, Article 130 of the Law on Credit Institutions (amended and supplemented) for 6 consecutive months.

- Ignoring the positive signs at the beginning of the session, the market quickly lost its gaining momentum when it met the resistance level of 1,370 points. Going against the selling pressure of the market, individual investors returned to net buying more than 400 billion dong. Cash flow concentrated in large-cap stocks such as MBB, HPG, SSI, FPT.
