

- Total newly registered FDI capital nationwide in 8 months was estimated at 19.12 billion USD, down more than 2% over the same period last year. Meanwhile, realized FDI capital reached 11.58 billion USD, up 2% over the same period. FDI capital from Singapore partners is 1.9 times higher than Japan and nearly 2.6 times higher than capital from Korea in the past 8 months.
