



- Asian stocks mixed, investors watched Evergrande. The Japanese market is trading again after a holiday on September 20. Nikkei 225 fell 0.34%. Mainland China and Korean markets are on holiday. Hong Kong's Hang Seng Index rose 1.32% after plunging more than 3% in the previous session. Hong Kong-listed Evergrande shares fell 0.44%, while the Hang Seng Properties real estate index rose 2.97%.

- According to the data released by the SBV, as of August 31, 2021, credit institutions have exempted, reduced or lowered interest rates for over 1.13m customers with outstanding loans of over VND 1.58m billion; New loans with lower interest rates than before the epidemic with accumulated sales from January 23, 2020 to date reaching VND 4.46m billion for 628,662 customers.




# Top most traded tickers (Volume - in million)
