The Chinese market fell with the Shanghai Composite down 0.47% and the Shenzhen Component down 0.9%. Hong Kong's Hang Seng fell 1.29%. South Korea's Kospi index fell 0.51%, the Kosdaq gained 0.15%. Australia's ASX 200 rose 0.13%. The market was not positive due to inflation concerns, as UK CPI rose above forecasts and supply constraints affected new home construction in the US.


