US stocks continued to decline on Friday (January 7) and closed the first trading week of the year with a rather difficult time, when technology stocks were battered by interest rate hikes. At the end of the session, the Nasdaq Composite index dropped 0.9% to 14,935.90 points. The S&P 500 index lost 0.4% to 4,677.02 points, witnessing its first four-day losing streak since September 2021. The Dow Jones Industrial Average fell 4.81 points, or 0.01%, to 36,231.66 points.



According to the Vietnam Bond Market Association (VBMA), in December 2021, 80 individual corporate bond issuances took place with a total value of VND65,757 billion. In which, the banking industry leads in terms of bond issuance value with VND 46,926 billion, accounting for 71.36% of the total issued value. This ratio far exceeds the level of 9.97% - equivalent to a value of VND 6,558 billion - of the group with the second largest issuance value, which is real estate.
