



At the end of the session, the VN-Index fell below the pre-Covid-19 epidemic zone, the market capitalization "evaporated" USD120 billion from the beginning of the year. A rare bright spot was that foreign investors net bought more than VND1,000 billion on November 15, extending the recent net buying chain. In this session, they mostly bought STB, HPG, and SSI.

The first session of the week (November 14) recorded net withdrawal of the State Bank (SBV) on the open market. Specifically, the SBV has lent nearly VND6,472 billion to 5 new market members through the channel of pledging valuable papers with a term of 14 days, with an interest rate of 6%/year. While there were VND12,827 billion of loans due at the end of October.
