
European shares decreased slightly on Tuesday, with a lack of fresh economic data from the region and uncertainty around the direction of global interest rates keeping investors cautious.

On the 4th of July session, the SBV listed the central exchange rate at 23,804 VND/USD, a slight decrease of 1 VND compared to the previous session. The spot buying rate was kept unchanged at 23,400 VND/USD. The spot selling rate is listed at 24,944 VND/USD, 50 VND lower than the ceiling rate.



Session 4/7, proprietary traders net bought more than VND190 billion, mainly including VSC VND134 billion, STB VND28 billion. On the contrary, they net sold KDC VND51 billion, NAB VND50 billion, SHS VND41 billion.
