The Nasdaq ended higher and the S&P 500 also rose on Monday, with shares of Nvidia jumping as investors were optimistic ahead of its earnings this week. The technology sector (.SPLRCT) gave the biggest boost to the S&P 500 and Nasdaq, while an index of semiconductors (.SOX) advanced 2.8%. Nvidia is expected to forecast quarterly revenue above analysts' estimates when it reports late on Wednesday.

Oil prices were up in early trade on Tuesday ahead of data later expected to show a draw in U.S. crude oil and gasoline inventories, though persistent concerns over a slowdown in China's economy limited the upside.

On August 21, proprietary traders net bought more than VND539 billion, mainly including VIT VND81.5 billion, HPG VND37.5 billion. On the other side, STB was sold the most with a value of VND35.5 billion.


