The S&P 500 Index prospered on Monday (September 25) to kick off the last trading week of September, after witnessing a sharp decline from the beginning of the month. Dow Chemical Corporation stock is the best performing in Dow Jones, up 1.7% after being upgraded by JPMorgan. 8 out of 11 S&P 500 sectors recorded green, with energy leading the gain, adding 1.3%.

Oil prices were mostly flat in a volatile session on Monday (September 25), as Russia eased its fuel export ban and investors noted rising interest rates that could limit demand.

On September 25, proprietary traders net bought more than VND493
billion, mainly including HPG 70VND billion, MBB VND61 billion, MWG
VND53 billion, etc. In contrast, they mainly net sold GEX VND81 billion.
