


Oil prices lost more than 2% on Monday as the Middle East conflict's limited impact on crude output prompted profit taking after oil benchmarks gained 2% last week. Several tanker owners steered clear of the Red Sea and multiple tankers changed course on Friday after U.S. and Britain launched strikes against Houthi targets in Yemen.
