Oil prices rose on Thursday, January 18. as the International Energy Agency (IEA) joined producer group Organisation of Petroleum Exporting Countries (OPEC) in forecasting strong growth in global oil demand and as cold winter weather disrupted US crude output while the government reported a big weekly draw in crude inventories.

In the January 18 session, proprietary traders net bought VND515 billion, mainly including PNJ VND66 billion, VIX VND50 billion, MBB VND46 billion.
