

Gold prices stabilized on Friday (March 15) but recorded the first weekly decline in four weeks, as investors lowered expectations for US interest rate cuts.




On the March 15 session, proprietary traders net bought VND71 billion, mainly including PLX VND28 billion, VNM VND20 billion, GAS VND20 billion,...
