
The Nasdaq and S&P 500 posted modest gains on Tuesday, a day ahead of major inflation data. Wednesday's hotly anticipated Consumer Price Index (CPI) is at the top of most investors' minds as they tweak expectations on the timing and extent of the Federal Reserve's ratecutting phase, following robust economic data such as last Friday's blockbuster employment report.


