
The S&P 500 and Nasdaq Composite closed at fresh record highs on Monday, as Nvidia shares boosted tech stocks and investors awaited the Federal Reserve's interest rate decision. The Fed's latest rate decision and May consumer price index (CPI) data due on June 12 could be key tests for markets, especially after a strong jobs report on June 7 continued to suggest the central bank may hold off on cutting rates.


