
The S&P 500 and Nasdaq notched record-high closes on Monday as investors awaited fresh inflation data and the start of quarterly earnings season. Nvidia rose nearly 2%, Intel rallied over 6% and Advanced Micro Devices added 4%. Boeing gained 0.55% after the planemaker agreed to pay a fine of USD243.6 million to resolve a U.S. Justice Department investigation into two fatal 737 MAX crashes.



The U.S. dollar hung near a multi-week low versus major peers on Tuesday as traders awaited testimony from Federal Reserve Chair Jerome Powell for clues on the path of interest rates. The euro held its ground after Monday's sharp swings as investors come to terms with a hung parliament in France.
