The DJIA and S&P 500 closed lower on Wednesday as investors awaited economic indicators and signals on upcoming interest rate cuts. Apple shares slipped 0.52% as sales of foreign-branded smartphones, including iPhones, in China fell in August on an annual basis, data from a government-affiliated research firm showed.



At the end of September 25, the price of SJC gold bars was traded at 81.5-83.5 million VND/tael (corresponding to buying-selling), unchanged from the previous session. Thus, the price of SJC gold bars was about VND10 million higher than at the beginning of the year.



On September 25, VNIndex increased strongly with the highest liquidity in 5 weeks, approaching the old peak of this year. Banking, financial services and basic resources were the most positive sectors. Proprietary traders net sold VND447 billion, mainly including MBB VND61 billion, SSI VND52 billion.
