
The S&P 500 scored a record closing high on Thursday, as Micron Technology shares rallied and a strong U.S. jobless claims report eased labor market concerns. Shares of Micron Technology rose 14.7% after the memory chip maker projected first-quarter revenue above expectations, highlighting strong demand for memory chips used in artificial intelligence computing.



Brent oil prices fell for a third day on Friday, on course to end the week lower, as investors focused on expectations of higher supplies from Libya and the broader OPEC+ group of oil exporters.



On September 26, VNIndex approached the two-year peak. Banking, oil and gas were the most positive sectors. Proprietary traders net bought VND39 billion, mainly including TCB VND272 billion. In contrast, they net sold BWE VND462 billion.
