The Nasdaq and the S&P 500 gained on Thursday, driven by Tesla's positive earnings forecast and a decline in Treasury yields from a threemonth high, which buoyed market sentiment despite declines from some corporate results. Shares of Tesla soared 21.9%, after it reported robust third-quarter profits and surprised investors with a prediction of 20% to 30% sales growth next year.


Oil prices eased about 1% in volatile trade on Thursday on reports the U.S. and Israel will try to restart talks on a possible ceasefire in Gaza.


