


Wall Street stocks ended Tuesday's trading session in positive territory, supported by a rebound in technology shares. Meanwhile, President Donald Trump announced plans to impose a conditional 25% tariff on imports from Canada and Mexico if they violate the free trade agreement he negotiated during his previous term. Additionally, he proposed implementing an additional 10% tariff on imports from China.

Oil prices continued to decline on Tuesday, extending the downward trend from the previous session after Israel reached a ceasefire agreement with Hezbollah, reducing oil's risk premium. Brent crude futures fell by over 0.2%, settling at \$72.8 per barrel.



VNINDEX showed positive performance, breaking the 1,240 resistance but not meeting follow-through criteria. Notable stocks during the session included DXG +1.18% and TCH +2.62%. Proprietary trading recorded a net buy of VND82 billion, primarily driven by net purchases of PNJ VND89 billion and SCG VND44 billion.
