



Oil prices ticked up on Thursday after Israel and Lebanese armed group Hezbollah traded accusations that their ceasefire had been violated, and as Israeli tanks fired on south Lebanon.



VNINDEX missed the 1,250 point mark, with FPT remaining the top net-bought stock by foreign investors, totaling over VND228 billion. On the other hand, proprietary traders recorded a modest net sell of nearly VND50 billion yesterday, focusing on VHM VND32 billion, VIB VND18 billion, and VPB VND11 billion.
