



Oil prices edged lower on Friday and posted a weekly decline of more than 3%, pressured by easing concern over supply risks from the Israel-Hezbollah conflict and the prospect of increased supply in 2025 even as OPEC+ is expected to extend output cuts.



VNINDEX recorded a positive trading session led by the Insurance sector, followed by FPT reaching an all-time high. In the previous session, proprietary trading desks recorded a net sell of over VND115 billion, primarily offloading VND67 billion of PNJ, SSI VND26 billion and VIB VND22 billion.
