

Gold prices slid 1% on Thursday as the U.S. dollar firmed ahead of a key jobs report and investors took profits, after bullion recorded consecutive record peaks in the previous five sessions on the back of escalating trade tensions between the U.S. and China.



VN-Index extended its three-day winning streak. Proprietary traders posted a net outflow of approximately VND175 billion yesterday, mainly in GEE VND122 billion, PC1 VND86 billion and FPT VND28 billion. On the other hand, they recorded inflows into OCB VND57 billion and LPB VND36 billion.
