

US stocks fell slightly on April 15 as investors digested the first financial reports for the first quarter of 2025. Bank of America and Citigroup shares rose 3.6% and 1.8%, respectively, after announcing first-quarter business results that exceeded analysts' expectations. Boeing shares fell more than 2% after Bloomberg reported that Beijing had ordered Chinese airlines to stop accepting more Boeing planes.




Gold prices extended gains on Tuesday (April 15), supported by safehaven demand as US President Donald Trump's tariff plans made investors wary of trade policy, while a weaker US dollar also supported bullion.



VNIndex faced profit-taking pressure after 3 consecutive increasing sessions. Proprietary traders net sold more than VND650 billion, mainly including ACB VND72 billion, MWG VND59 billion, CTG VND49 billion, VPB VND44 billion, etc.
