In a Thursday morning vote, members of the U.S. House of Representatives passed a bill that includes tax cuts and increased military spending. The measure — now sent to the Senate — could raise U.S. government debt by trillions of dollars. Major stock indexes in the U.S. were mostly flat in yesterday's trading session.


Bitcoin continued its historic rally overnight, ending the latest trading session near its intraday high at 111,743 USD/BTC.



VN-Index showed strong distribution at its previous peak. Proprietary trading desks of securities firms continued to net sell nearly VND358 billion, focusing on TCB (VND127 billion), GEX (VND38 billion), STB (VND37 billion), and MWG (VND32 billion). On the other hand, they net bought primarily HPG (VND30 billion), NLG (VND27 billion), and VND (VND8 billion).
