The U.S. has determined that Vietnam is not manipulating its currency;

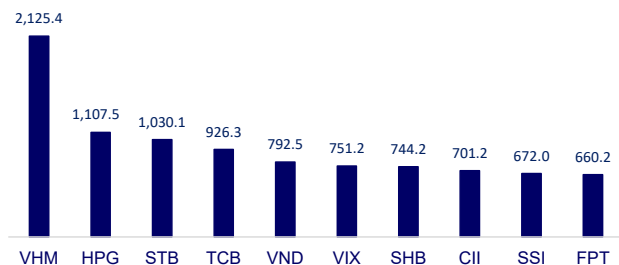
India unexpectedly cut its interest rate sharply to 5.5%, the lowest level in nearly three years;

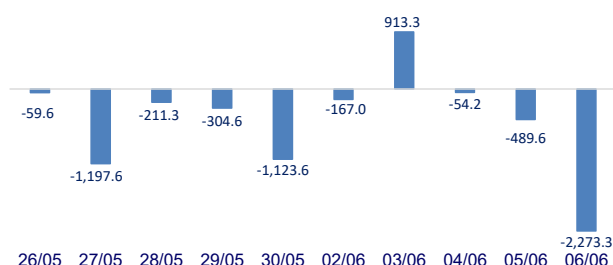

However, during the post-merger integration (PMI) process — which involves aligning management, business operations, and systems — AEON Financial Services discovered that the accounting information disclosed prior to the agreement significantly differed from the actual figures. For this reason, AEON Financial Services has issued a notice to SeABank requesting the contract be declared null and void, effective from June 6, 2026.

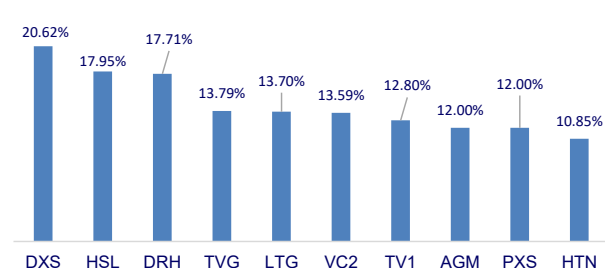
Top highest total traded value stocks (Billion VND)
