


Global oil prices jumped more than 6% immediately after Israel struck Iran early this morning, targeting "dozens" of nuclear facilities.

VN-Index reversed course and climbed, with liquidity reaching nearly VND20 trillion—an increase of nearly VND4 trillion compared to the previous session. Proprietary continued net buying VND331 billion yesterday. Key stocks bought included FPT (VND54 billion), HPG (VND35 billion), and VPB (VND31 billion). In contrast, they net sold DGW (VND18 billion) and VCB (VND10 billion).
