

According to the report, the consumer price index (CPI) for November rose only 2.7% year-on-year, lower than the 3.1% estimate from economists surveyed by Dow Jones.



Oil prices moved in opposite directions during trading on December 18th, as investors weighed the possibility of further US sanctions against Russia, along with supply risks arising from the blockade of Venezuelan oil tankers.
